- ✘ Not operational - 5 enacted but not operational
- ✘ Still fighting -2 (Oregon and Florida)

Steps to Incorporation

1. Reviewed Options:
Dissolve Alliance or Become Independent
2. Voted to Incorporate
3. Filed papers
4. Drafted and then Accepted By-Laws
5. Elected Officers And Board of Directors
6. Appointed Executive Director

Partnering with Brandeis for Technical and Training Assistance

- The Bureau of Justice Assistance (BJA) through the Harold Rogers Prescription Drug Monitoring Program is making available a host of technical services to BJA grantees and other states who may be interested in implementing or enhancing a Prescription Drug Monitoring Program (PMP).
- The training and technical assistance will be provided by Brandeis University in partnership with the Alliance. Training and technical assistance is provided to states who wish to enhance their existing PDMP or states planning or implementing a new PMP.
- The Brandeis/Alliance partnership gives grantees and other states a single point of contact and provides readily available and up -to- date training and technical assistance.

WHY BRANDEIS?

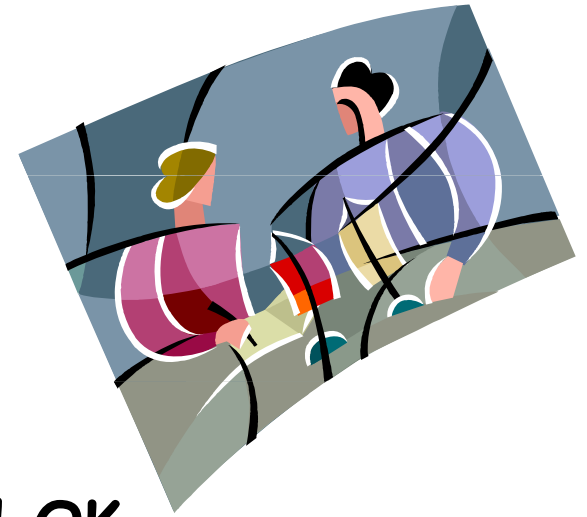
