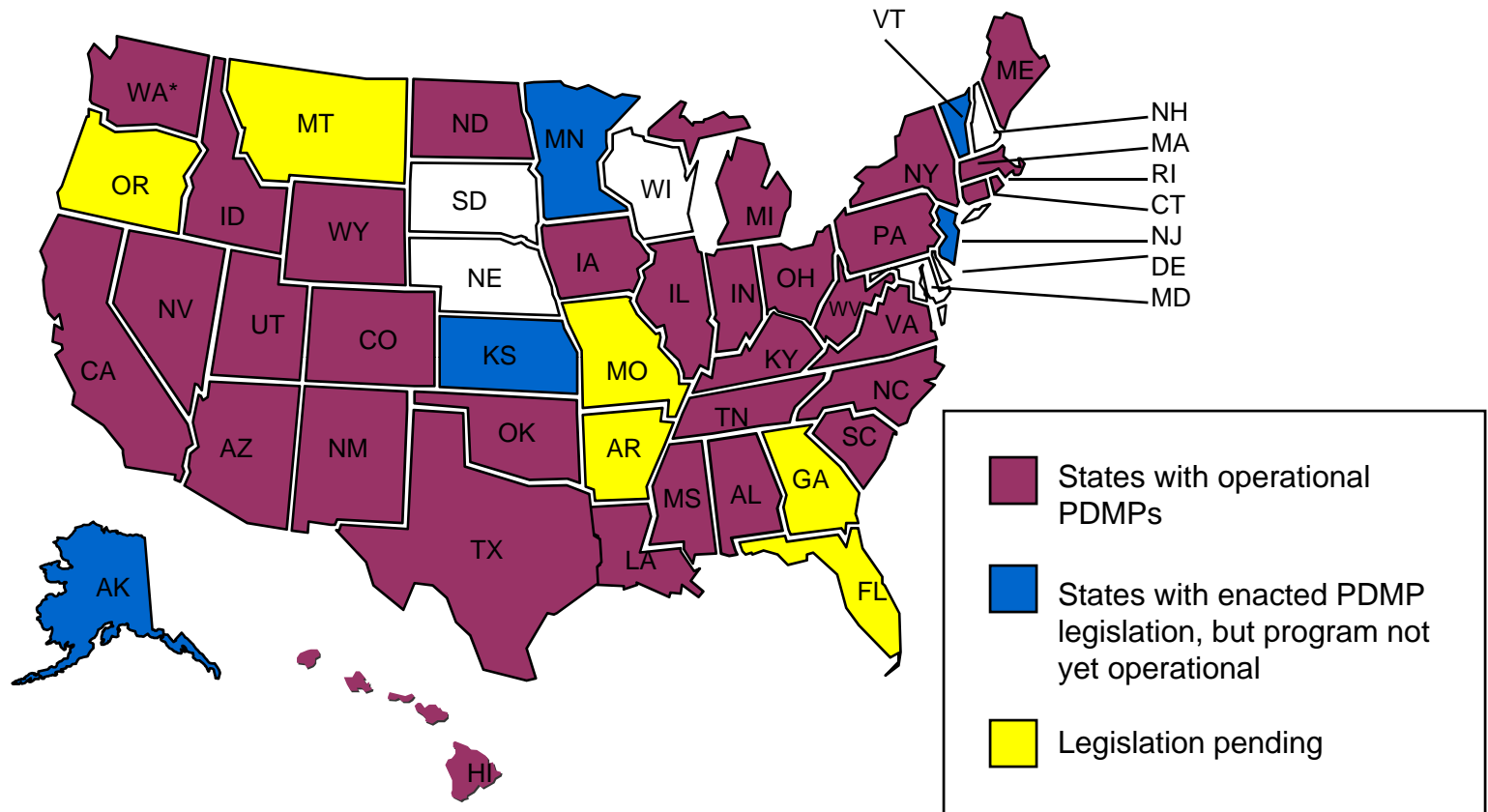

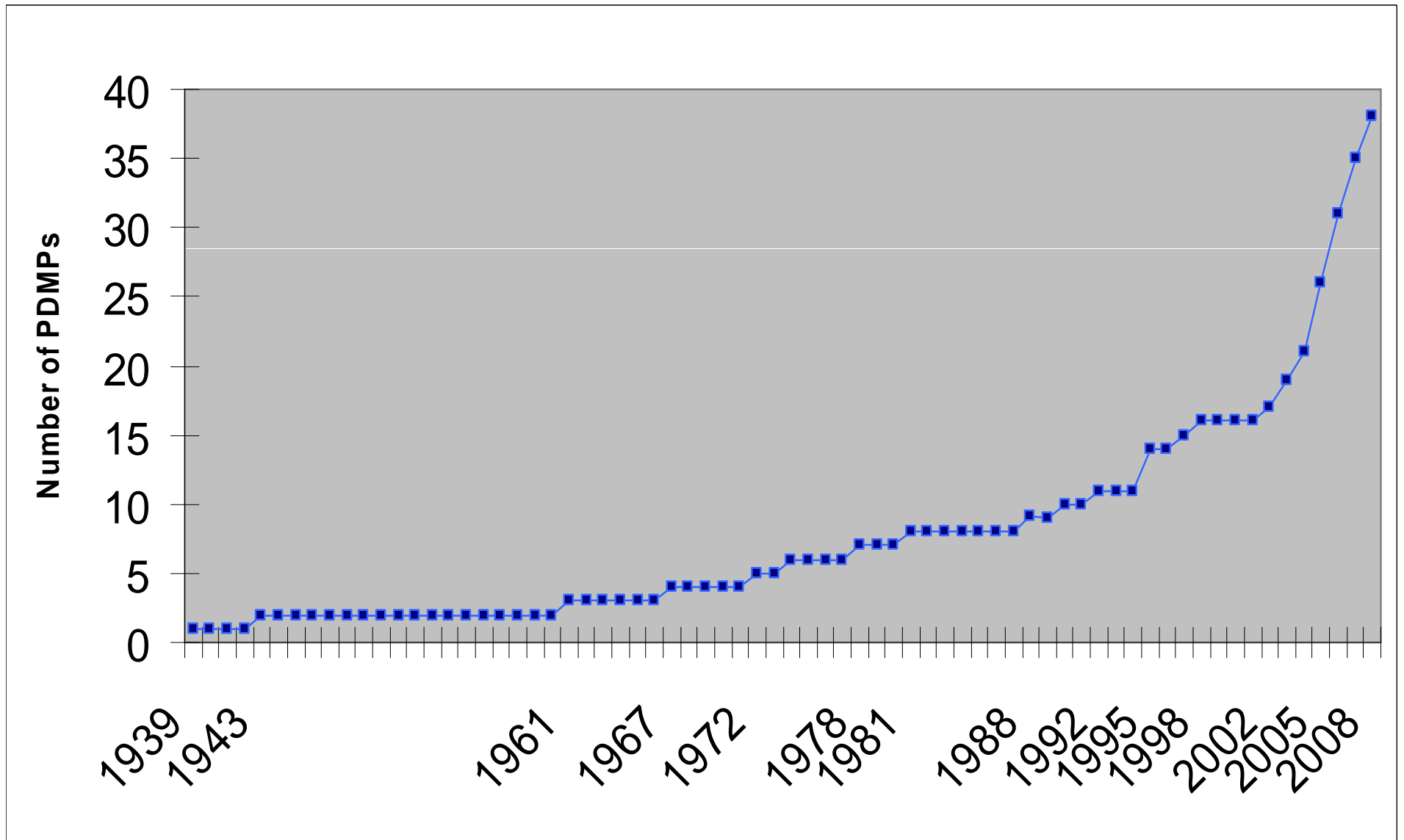

Status of State Prescription Drug Monitoring Programs (PDMPs)



*Washington has temporarily suspended its PMP operations due to budgetary constraints.

Premises of the PDMP Training & Technical Assistance Center

- Tremendous growth in the number of states with PDMPs since the 2002 Harold Rogers legislation
- Coupled with technological change, expansion and increased visibility of PDMPs
 - Many newer state PDMPs
 - Great variation in the context, operations, and resources of state PDMPs
 - Corresponding need to document and understand PDMP similarities and differences
 - What difference do the differences make?
 - Best practices?

Premises of the PDMP Training & Technical Assistance Center

- There is a wealth of experience and expertise among the “older” state PDMPs
 - Existing mentoring of newer PDMPs
 - Can the mentoring be carried out in a more systematic way?
 - Can what has been learned by older and newer PDMPs be captured, organized, and disseminated to all PDMPs?
 - What are the best ways for PDMPs to share knowledge and expertise and support one another in continued learning?

Premises of the PDMP Training & Technical Assistance Center

- Conversely, the many “newer” state PDMPs have become operational in a different context
 - Technological advances
 - High visibility of prescription drug abuse
- What are the emerging issues for newer PDMPs?
 - Develop a more systematic way for all PDMPs to frame and address these issues
 - Benefit to “older” PDMPs seeking to enhance their systems

Premises of the PDMP Training & Technical Assistance Center

- Increasing amount of written materials about PDMPs – research, policy documents, position papers, legislative background studies
 - Corresponding need to gather, organize, and assess this material and make it available in a user-friendly format
 - An opportunity for PDMPs to identify and help shape research that would be useful to them

Premises of the PDMP Training & Technical Assistance Center

- Given all of the above, there is an immediate need for the PDMP TTA Center to ramp up quickly to serve PDMPs
- At the same time, in order to be responsive to changing needs, the Center needs PDMP input and feedback early and often – implying an implementation in stages
 - Web site
 - Regional PDMP meetings
 - National BJA/PDMP meeting
 - Conference calls, e-mail

Purpose of the PDMP Training & Technical Assistance Center

To be a flexible, responsive resource to BJA, state PDMPs, and other stakeholders in

- Compiling, organizing, assessing and making available in a user-friendly way PDMP materials, research findings, legislation, etc.
- Facilitating exchange of knowledge, expertise, and tools among PDMPs
- Developing trainings to address emerging needs among PDMPs
- Tailoring technical assistance to individual PDMPs
- Helping to organize the “voice” of PDMPs

Brandeis/Alliance Partnership

- What the Alliance brings to the TTA Center
 - Members are the experts
 - Experience in providing TA
 - Members are the TTA recipients
 - Experience in identifying TA needs, working with TA provider
 - History of facilitating interstate mentoring
 - Patterns of local assistance, sharing, collective learning
 - Alliance increasingly giving voice to state PDMP concerns, views, experiences
 - Is there a need for a collective PDMP voice?

Brandeis/Alliance Partnership

- What Brandeis brings
 - Research expertise in substance abuse/prescription drug abuse issues, assessment, prevention and tx
 - How does the work of PDMPs fit into this larger context?
 - What in this context do PDMPs need to pay attention to?
 - Expertise in evaluating state PDMP, collaboration networks, and TTA
 - How can the TTA Center's work intelligently build upon and extend existing interstate relationships and networks?
 - Expertise in compiling, assessing, and organizing literature
 - Allow state PDMPs to explore in depth as needed

 - Help with updating PDMP Model Act
 - Develop and disseminate “best practices”
 - Help improve BJA performance measure reporting
